BASIC INFO

DEMOGRAPHICS

Smoking history/ Co-morbidities /Stress testing/Ambulatory status/Functional status/Hemoglobin/ Creatinine/ Pre-procedure medications including but not limited to:
Antiplatelet/ Statin/ Beta Blocker/ACE Inhibitor; ARB/ Chronic Anticoagulation

HISTORY

Prior Central Nervous System (CNS) events/Rankin score if history of prior stroke/History of prior neck radiation /High risk for Carotid endarterectomy(CEA) /Refusal for CEA /Prior Vascular History

Study Results: Duplex/MRA/CTA/Arteriogram

PROCEDURE

COVID status/Urgency/Anesthesia type/ASA class/Arch type/Number of lesions treated/ Lesion type /Protection device details/Balloon and stent details/ Procedure details including intra-procedural medications/Approach/ Flow reversal time

POST-PROCEDURE

New CNS event/ Post op Rankin score if new stroke/Complications / Discharge Medications / Discharge status / Death if applicable

30-DAY FOLLOW-UP (optional)

Captured within 30 days from discharge/ Admission status since discharge/Reason for readmission if applicable /Reintervention related to primary procedure if applicable

LTFU

Captured between 9-21 Months: Current smoking status/Living status/Mortality/ Medications/Cardiac or CNS events/Duplex or other imaging findings/Any re-intervention

Center level comparisons to Regional and National data/ Risk Adjusted asymptomatic and symptomatic Transfemoral (TFEM) and Transcarotid Artery Revascularization (TCAR) Carotid Artery Stenting for stroke and death / Over All LTFU completion / Discharge Medications/Case Volumes
