### General Discussion and Questions

- a. Should toe amputations planned and/or unplanned count against facilities in the infra module under return to OR?
- b. What counts as pre-op vein mapping? Melissa Latus clarified that it can be collected until incision/procedure start time. More education and documentation may be needed.

- c. LTFU completion percentage was suggested to be weighted by module and number of procedures rather than a computed %.
- d. Follow up with RMVS meeting to add VQI portion—completed.
- e. QI charters being done in RMR—suggestion made to share within the group any charters that centers can participate in.
- f. Leave data points blank if unable to find or unable to collect rather than adding unknown to the drop down.
- g. Ask about unblinding medications within the report.
