II. <u>General Discussion and Questions</u>

- a. Data Manager's Meeting:
 - i. Discussed how each site collects missing data elements not found in patient charts.
 - 1. Forms sent to physicians to fill out, email, or none
 - ii. How centers generate scorecards? What platforms are used?
 - 1. Tableau and Pathways reports
 - iii. Interest in setting up email groups for centers with the same EMRs. We can use each other as resources, to share reports built, and to improve processes

- b. Melissa discussed the Physician Snapshot Reports for the carotid registries.
 - i. Some physicians voiced they didn't receive the email
- c. Discussion regarding ultrasound vein mapping for HDA cases
 - i. Does it count if done in OR? Yes, if it is documented by the surgeon
 - ii. It was mentioned that there are 2 places to record vein mapping on the abstraction sheet- in the pre-op history and the intra-op details. -*Melissa looked at the abstraction form and only found one place on the form to abstract the pre-op vein mapping.*
 - iii. Why is this still a requirement? *Dr. Mousa mentioned that it's no longer a DOQI requirement*
- d. AAA module can we find out how many are conversions/redo?
- e. Discussion after Dr. Pillai's presentation regarding how patient's are selected for trans-radial vs trans-femoral approaches. Also discussed the use of new catheters for radial access.
